## Change in Refund Policy for CCAS Seminars and the Annual Meeting

The CCAS Board of Directors has approved a new, more liberal refund policy for those who must cancel their registration to seminars or workshops. Effective immediately, **for written cancellations** received in the CCAS office by 5:00 MST of the deadline date (generally three weeks from the start of the seminar), CCAS will refund the registration fee less a 10% administrative fee. Between the deadline date and the start date of the seminar, **for written cancellations** CCAS will refund 50% of the registration fee. No refund will be provided to those who fail to show for the seminar without prior written notice.

## MEMBERSHIP RENEWALS

Your 2001-2002 membership renewal information will be sent to you shortly. You will be asked to confirm your membership entry, including names, email addresses, and phone numbers for you and your associate and assistant deans. Updating this information ensures that we accurately represent your institution in the 2001-2002 *CCAS Membership Directory*.

You can update your information on the CCAS web site at <http://www.ccas.net/>. This will automatically be entered into a database, which will be used to update our information.

Please provide your nine-digit US Zip Code. This information will facilitate efficient mailings to you and will save the organization some postal fees on larger mailings.

Note that your dues payment does not have to accompany your renewal. It is imperative that confirmation of your renewal and any updates and corrections be received in the CCAS office as soon as possible. Please return your renewal information promptly; please fax this information, if possible.

Often staff and address changes are not received before the deadline. The consequence is incorrect data on file at CCAS and in the *Membership Directory*. **Please, either confirm the accuracy of your data or inform us of changes.** Our goal is an accurate entry for you and your institution. **Note:** Because Carnegie has changed their classification system, we have added Carnegie Classifications on the renewal form this year. Please circle the classification appropriate for your institution.

### →REMINDER ABOUT CCAS MEMBERSHIP←

The CCAS Member is the INSTITUTION not the Dean or the individual College. When the institution calculates the number of degrees, remember to include all degree-granting colleges of arts and sciences disciplines in the total. It is up to the institution to divide the dues among the colleges. Some institutions divide the dues equally, some institutions divide the dues based upon the size of the college, and others rotate the dues responsibility between colleges on a yearly basis. Deans, please speak with your colleagues and determine your institution's method.

If a Dean moves from a CCAS member institution to a non-member institution, the Dean must apply for CCAS membership for the new institution to have the benefits of CCAS membership.

## Beaver College changes name to Arcadia University

The Commonwealth of Pennsylvania recently awarded Beaver College "university" status. In recognition of their enhanced academic position, they have changed their name to Arcadia University effective July 16, 2001.

## Utah Valley State College Wins Hesburgh Award

Utah Valley State College is the winner of the 2001 Theodore M. Hesburgh Award, which recognizes innovative undergraduate faculty development programs. Utah Valley State College (UVSC) received the award for their "Faculty Excellence Through Ethics Across the Curriculum" (EAC) program.

In addition to the Hesburgh Award winner, four institutions were selected to receive Certificates of Excellence. Metropolitan State College of Denver, Denver, CO, was recognized for Bringing Adjuncts in from the Cold: The MSCD Experience, which uses full-time faculty to assist adjunct faculty to improve classroom skills and overall excellence; Missouri Southern State College, Joplin, MO, for Bringing the World to the Midwest: The International Mission at MSSC, a program enabling the majority of full-time teaching faculty to have an international experience which they can later share in the classroom with students; University of Wisconsin System, Oshkosh, WI, for the Women and Science Program, which is designed to attract and retain more female and minority students in science and related fields through faculty development in creating improved classroom climates and better teach-

ing; and the University of Nebraska at Omaha, Omaha, NE, for The Goodrich Scholarship Program, a multicultural program which provides financial support for faculty development programs to deal with problematic situations arising from a predominately white institution.

### Former CCAS President Writes About Early CCAS History

E. Gerald Meyer, former CCAS president recently wrote to CCAS Past President Phil Certain about the early days of CCAS:

"Dear Dean Certain:

CCAS favors me in sending the Newsletter (which I edited for many years), and I enjoy reading the various items. Your Presidential Address was excellent and of particular interest in that it set the stage (in my case reset the stage) regarding CCAS.

You might be interested to know that what is now NASULGC was once two national organizations, one for non-land grant state universities and the other for land grant state universities. When the two combined the role of arts and sciences seemed to many of us to be substantially reduced (e.g. there was a Division of Agriculture and a Commission of Arts and Sciences). So a group of us decided it was proper to establish a separate organization. As I remember, the group included Os Fuller of Ohio State, Spoff English of Missouri, Walt Militzer of Nebraska, myself, and a few others. Originally CCAS was intended for the A&S deans of the NASULGC institutions, and of course, was expanded to encompass a much wider group. I am proud of having played a role in the early days of CCAS.

One other item that may be of interest, when I first started "deaning" almost all of my fellow deans were from the humanities and social sciences (I, like you, am a chemist). This has certainly changed over the years, and now there is a balance of disciplines represented.

Dr. Tom Brzustowski, president of NSERC (National Science and Engineering Research Council) will be present, and the following topics, among others, will be discussed by the participants: Research funding, Canada Research chairs, Relations between Science faculties and Professional faculties, and the funding of science education.
