Dear CCAS members,

We are deeply saddened by the loss of life in the tragedies of New York City, Washington, DC and Pennsylvania. On behalf of CCAS and its Board of Directors we wish to extend our condolences and support.

"As the consequences of September 11th's terrorist attacks begin to sink in, each of us must try to cope with the changes this cataclysm has wrought in our own daily agendas. Even those whom death has not directly touched sense that American life -- in private and in the public sphere -- has been irrevocably altered, even as it continues to evolve. In this uncertain context, where reactions are both complex and unresolved, it is hard to know what weight to give to one's profession or how to properly assess its value. And yet if colleges and universities are to remain places where confusion can be faced, conflicting voices heard, and profound differences civilly debated, it is crucial that, maintaining our collective identity, we do continue to examine and define our institutional visions and priorities. The Program of our meeting in November permits reflection on the extent to which our enduring concerns as Arts and Science deans -- organizing the curriculum, developing and deploying resources, defining the significance of a liberal arts education for the citizens of a democracy -- will help shape the nation's political and ethical responses to an attack on its borders, institutions, and sense of its own ideals." The Annual Meeting is still scheduled for November 7-10, 2001 as originally planned. Rooms at the Washington Hilton and Towers and registration slots for the CCAS meeting are available. In accordance with the recommendations of President Bush and others in Washington, we encourage all CCAS members who were planning to attend the 2001 CCAS Annual Meeting to continue to do so.

We expect travel and security measures to be established by that time. However, we understand that some of you will need additional time to make arrangements to attend. In order to relieve some of this burden, the early registration fee deadline has been extended from October 5 to October 19. Registration and hotel information is available online at www.ccas.net.

We look forward to seeing you all in Washington, D.C.

2001 "Teacher Prep" Seminar Rescheduled

The 2001 CCAS / AACTE Seminar on Effective Collaboration in Teacher Preparation has been rescheduled for March 17-19, 2002. The seminar will be held at the same hotel as originally planned, The St. Louis Marriott Pavilion Downtown. Those registered for the September 2001 seminar will remain registered for the March 2002 seminar unless they choose to decline the March seminar in writing via FAX to the CCAS office (480-727-6078).

Within days of the tragedies of September 11, many seminar registrants phoned or emailed the CCAS office requesting information about the "Teacher Prep" seminar. Some questioned whether the seminar should/would be held. Others cancelled their registration, primarily because they could not obtain flight reservations or they could not be assured a reservation until 24 hours prior to departure.

Seminar directors Dorothy Abrahamse and Sandra Flake, together with the officers of the CCAS Board of Directors, considered the alternatives and asked that the CCAS office negotiate an alternate date for the seminar sometime within the next six months. This was accomplished on Monday, the 17th of September. The St. Louis Marriott Pavilion Downtown was very accommodating. Without penalty to CCAS, the seminar has been rescheduled for Sunday afternoon, the 17th of March, 2002 through noon on Tuesday, the 19th.

The CCAS office is hopeful that this date will fit the schedules of most of the original registrants. Anyone choosing to attend on the new dates will have his or her original registration and fees honored. Anyone choosing to cancel will have his or her fees returned. Because some current registrants will be unable to attend the March seminar, slots will open for new registrants. The CCAS office will take applications for positions on a waitlist starting immediately. 2001 CCAS ANNUAL MEETING INFORMATION FOR PARTICIPANTS

For the new Deans and Associate Deans who came aboard after our original Annual Meeting mailing, we have enclosed pre-registration forms in this newsletter. Pre-registration materials are also on the CCAS web site (www.ccas.net) in the Annual Meeting section.

The registration desk will open at 11:00 a.m. on Wednesday and remain open until 9:00 p.m. Registration will be open between 7:00 a.m. and 5:00 p.m. Thursday and 7:00 a.m. until noon on Friday in the Concourse. Remember to bring your registration materials with you to the meeting. CCAS will charge \$10.00 for replacement programs and will have a very limited supply on hand.

Also check to see that your 2001-2002 CCAS membership dues have been paid prior to attending the meeting. Your institution's dues must be paid in order to vote at the CCAS Annual Business Meeting on Friday, November 9. Those registrants who registered at the member rate and whose institutions still have not paid 2001-2002 dues will be invoiced for the difference between member and non-member fees.

All registrants must make their own travel and hotel arrangements. Contact The Washington Hilton and Towers at 1-888-DC-Hilton for reservations.

Additionally, we are aware that the Washington Hilton and Towers has a hotel policy of charging one night's rental to credit cards for holding rooms. The CCAS office has complained to the hotel, both personally and through our contracting agent, CONFERON. However, this is reported to be "standard" practice for the Washington Hilton as well as other DC hotels. There appears nothing we can do about it. However, Ernie Peck will continue to negotiate a less burdensome procedure.

2002 CCAS Deans' Seminar

DEAN, COLLEGE OF NATURAL SCIENCES, COLORADO STATE UNIVERSITY

Colorado State University continues the search and invites applications and nominations to fill the position of Dean, College of Natural Sciences. The desired starting date is on or before July 1, 2002. The Dean is the chief academic and administrative officer of the College and reports directly to the Provost/Academic Vice President. The Dean is a member of the Council of Deans.

The College of Natural Sciences is one of eight colleges within Colorado State University. The College is composed of eight departments: Biochemistry and Molecular Biology, Biology, Chemistry, Computer Science, Mathematics, Physics, Psychology, and Statistics. The Center for Science, Mathematics, and Technology Education (CSMATE) is partially supported by the College. Currently the College has 189 tenure-track and 39 non-tenure-track faculty positions, 133 professional and classified staff members, 81 postdoctoral fellows, and nearly 400 graduate assistants. It enrolls approximately 3,100 undergraduate and 560 graduate students with about 500 Bachelors, 75 Masters, and 50 Ph.D. degrees conferred last year.

The College of Natural Sciences is a partner in ongoing university interdisciplinary initiatives in information science and technology and life sciences. The College houses or shares four of the University's Programs of Research and Scholarly Excellence: Biochemistry and Molecular Biology, Chemistry, Tri-Ethnic Center for Prevention Research, and Molecular, Cellular, and Integrative Neurosciences. The Colorado Commission on Higher Education has named the Department of Chemistry a Program of Excellence. One of the University Distinguished Professors is a Natural Sciences faculty member, as are two of the University Distinguished Teaching Scholars.

Recently completed construction and renovation projects include: renovation and addition for the Department of Physics, renovation of existing buildings for Mathematics and Statistics, and renovation of the facility for the Tri-Ethnic Center. Construction of a major instructional facility to house chemistry and biological sciences teaching laboratories is currently underway. The Macromolecular Resource Facility will be relocated to new quarters. Plans for construction of a new Computer Science Building are being developed. These new facilities will provide modern learning environments and research facilities for students and faculty.

The College offers 10 B.S. and 9 M.S. and Ph.D. degree programs as well as an interdisciplinary degree in Natural Sciences for science teacher licensure. Departments in the College participate in interdisciplinary graduate degree programs in Ecology and in Cell and Molecular Biology.

The College's annual instructional budget is approximately \$22.3 million per year, with an additional \$18.3 million in funded contract and grant expenditures and \$1 million in private donations. Please visit our website (<http://www.colostate.edu/Depts/NatSci/>) for addi-

Colorado State University has Carnegie Doctoral/Research University-Extensive status, with annual research expenditures of \$165 million and a total budget of \$482 million. With 19,075 undergraduates, 3,494 graduate students, 529 professional veterinary medicine students, and approximately 7,000 employees, Colorado State University is the flagship institution of the Colorado State University System (Colorado State University, the University of Southern Colorado, and Fort Lewis College).

Qualifications: The candidate must have an earned doctorate and have a documented record of teaching and research excellence sufficient to qualify for faculty appointment as a tenured Professor in the College.

The following attributes will be important in evaluating candidates:

- Evidence of effective administrative experience and leadership
- Evidence of ability to create and implement a shared strategic vision for the College
- Evidence of ability to develop and sustain strong College programs while addressing central University priorities
- Strong communication skills
- Ability to work with people of diverse backgrounds
- Success in developing and implementing interdisciplinary undergraduate and graduate curricular and research innovations
- Commitment to diversity of students and faculty and to programs enhancing cultural pluralism
- Success in working with the private sector to achieve development goals
- Commitment to K-12 collaboration

Lee R. Edwards, Dean of the College of Humanities and Fine Arts at the University of Massachusetts, Amherst. Lee R. Edwards has been Dean of the College of Humanities & Fine Arts at the University of Massachusetts, Amherst since 1991. As a CCAS member and regular attendee at Annual Meeting, she has organized sessions for Arts Deans, directed the Seminar for Department Chairs, chaired the Committee on Research Universities, and participated in the Seminar for Deans, the Fiscal Issues Seminar, and the Seminar (co-sponsored by AACTE) on Arts & Sciences, Schools of Education, and Teacher Preparation. Joseph E. Nadeau, Dean of the College of Liberal Arts, Education, and Sciences, Rider University. Joseph E. Nadeau is Dean of the College of Liberal Arts, Education, and Sciences, a small private university (~5500). Dr. Nadeau's experiences in teaching, international research, the corporate world, and consulting activities have provided a wide range of perspectives. He has served as a content specialist for the Federal Department of Education. He serves on the Barry M. Goldwater National Science Scholarship selection committee and on the Udall Environmental Policy Fellow selection committee. He has served on the Geological Society of America Second Century Committee; on the boards of trustees at The Peddie School, The Yellowstone-Bighorn Research Association, and the New Jersey Marine Sciences Consortium as well as on a number of advisory boards. Since becoming Dean four years ago he has attended CCAS each year and has responded to specific requests regarding workshops and program ideas. He served as a leader for Case Studies at the annual meeting, and participates in the CCAS Listserve. He has volunteered for both the Program Committee and the Liberal Arts Colleges Committee for each of the last two years. Along with two colleagues, he submitted a session proposal for next year.

Roosevelt Newson, Dean of the College of Fine Arts at Illinois State University. A fourteen-year veteran of CCAS, Roosevelt Newson's participation runs the gamut from registrant at the dean's seminar to Board member. Currently serving as Coordinator for the Department Chairs Seminar, Newson has participated in panel discussions and case studies at several recent annual meetings. Appointed in 1999 as Dean of the College of Fine Arts at Illinois State University, Newson's previous administrative appointments include five years as Dean of the College of Liberal Arts and Social Sciences at Georgia Southern University and six years as Associate Dean of the College of Arts and Sciences at Bloomsburg University in Pennsylvania. Risa Palm, Dean of the College of Arts and Sciences University of North Carolina, Chapel Hill. Risa Palm has been Dean at the University of North Carolina, Chapel Hill since 1997. Before that, she served as Dean of the Graduate School and Associate Vice Chancellor for Research at the University of Colorado Boulder (1987-91) and Dean of the College of Arts and Sciences at the University of Oregon (1991-97). In addition, she has been a faculty member at the University of California, Berkeley. She is a professor of geography, with a Ph.D. from the University of Minnesota. Her research specialization is urban geography and the human re-

sponse to earthquake hazards. She has been president of the Consortium of Social Science Associations (COSSA) and the Association of American Geographers, and has been on several panels for the National Science Foundation. Eswar Phadia has been a professor of Mathematics since 1973 and Dean of the College of Science & Health at William Paterson since 1996. He holds a doctorate in statistics from the Ohio State University. His CCAS activities include participation in the New Jersey deans meetings and panel discussions, as well as case study sessions, dean's clinic, and open forums and annual meetings. He has chaired a case study session in Seattle, and organized and hosted a round table discussion at the Toronto annual meeting.

Peter W. Rabideau, Dean of the College of Liberal Arts and Sciences at Iowa State University. Peter W. Rabideau has been dean of the College of Liberal Arts and Sciences and Professor of Chemistry at Iowa State University since 1999. A member of CCAS since 1990, Dr. Rabideau has served on the Committee on Internationalization of Education as well as on panels at annual meetings.

Ted Wendt, Dean of the College of Arts & Sciences at University of Wisconsin - Eau Claire. Previous decanal posts have included: Associate Dean of Humanities & Fine Arts at California State University - Chico; Dean of the School of Fine Arts & Communication at Cameron University; and Dean of the College of Fine Arts & Communication at Murray State University.
