he 2014 (incoming faculty for fall 2014) annual survey of salaries paid to incoming faculty (the CCAS "New Hires Survey") yielded responses from over 200 colleges of arts/sciences – public and private, large and small. The mean salary paid to new tenure-track assistant professors (N=1887), across all disciplines (not including baccalaureate institutions) was \$63,321. This represents a mere 1.8 percent increase over the mean salary of incoming assistant professors from the 2012 New Hires Survey (two years prior).

Regional differences range from a mean high of \$66,497 in the Northeast to \$61,096 in the Midwest. In past years, lowest mean salaries were found in the South. The difference between starting salaries offered to new faculty at private versus public institutions was negligible.



## From the President



TIMOTHY D. JOHNSTON 2014-15 CCAS President

he winter meeting of the Board of Directors in Washington, DC, was held in January at the site of our 2015 Annual Meeting (the Washington Hilton). Several of us were also able to visit the location of the Friday evening gala reception, part of our 50<sup>th</sup> anniversary celebration, at the National Press Club. This is a wonderful venue for what promises to be a splendid recognition of CCAS's history and accomplishments. I hope you will all make plans to attend the meeting and the gala, and that you will also consider submitting proposals for inclusion in the program.

As we do at every Board meeting, we reviewed the progress we have made on our work plan (the implementation of the goals established during our last strategic planning period) and I am pleased to report that we remain on track as we move into the development of our next strategic plan.

Your Board is a very hard-working group and, with Anne-Marie McCartan's very able assistance and persistent guidance, we have accomplished a lot in the last two years. Last summer, we began to work on a new strategic plan for 2015-18. In the course of a day-long session, led by then-President Nancy Gutierrez, we identified six priority areas on which we think CCAS should focus in the next three years. At the 2014 Annual Meeting in San Antonio, Nancy and I presented a session to invite feedback on the proposed priority areas, and we are incorporating that feedback as our planning continues.

To engage a broader cross-section of the membership we have engaged the services of a planning consultant, Leland Russell of GEO Group Strategic Services, LLC, and solicited a group of some 70 volunteer members to suggest refinements to the priority areas and propose specific steps we should take to implement them. This group is participating in three interactive on-line sessions in February and March and the Board will discuss the report from those sessions at its spring meeting in May and at a summer retreat. We will present the 2015-18 strategic plan to the membership at the Annual Meeting in November.

Also being developed this spring is a webinar series, on the topic of how deans can facilitate and support interdisciplinarity, both in academic programs and in research. A sub-committee of the Board, led by Jeff Braden of NC State University, is working on the content of the webinar, which will be delivered by an outside company. The Board launched this initiative in response to suggestions from you that we experiment with web-based delivery of workshops and seminars, as a way of providing professional development opportunities that do not require travel to a different location. Dates and registration information will be coming soon.

## **CCAS** to offer four-part series on Interdisciplinarity

# 2015 Humanities Advocacy Day



# **Looking for Training for Your Chairs/Heads?**


re you ready to take advantage of a unique benefit for CCAS members? The CCAS Leadership Development Workshops for Chairs/Heads brings our national training curriculum for chairs to campus. Designed for deans who are looking for a team-centered approach to enhancing the skills and confidence of its chairs, this workshop consists of a one-day visit from a dean-facilitator whom you have determined best matches the needs of your type of institution. You select from training topics, which include

- · The Chair as Academic Leader
- · Managing People and Conflict
- · Working with the Dean
- Recruiting, Retaining, and Developing Faculty
- Managing Resources
- Strategic Planning for Chairs

Case studies are used with each topic, and sessions are tailored to meet the needs of your setting.
