# From President-Elect Geoffrey Feiss: 2002 CCAS Annual Meeting Update

The 2002 Annual Meeting of the Council of Colleges of Arts and Sciences will take place from Wednesday, November 13 to Saturday, November 16, 2002. The headquarters hotel will be the Hyatt Regency Embarcadero in San Francisco. I encourage you to attend. If you have had a spring of budget cutting and retrenchment as I have, you will enjoy not only the camaraderie of fellow sufferers, but the intellectual excitement of the program we are developing and the lovely setting of our headquarters hotel. We will be a stone's throw from the Bay and a brisk walk or short trolley ride from Fisherman's Wharf, Ghiardelli Square, and the Presidio.

Your Program Committee is hard at work putting together sessions that we hope will inform and educate. As always, the theme is "Deans helping deans to be better deans." Among current highlights are the plenary address by Donald Kennedy, President-emeritus of Stanford University, Editor-in-chief of Science, and author of Academic Duty, a book I often recommend to young faculty. Our Thursday luncheon speaker will be P.F. Kluge, novelist and Professor of English at Kenyon College and author of a very insightful and entertaining book. Alma Mater, which is a great summer read. Of course, on Friday, we will have the presidential address and those of you who have had the pleasure to know our president, Lee Edwards, Dean of the College of Humanities and Fine Arts at the University of Massachusetts at Amherst, know that this event is well worth the trip in its own right.

Plan also to arrive early enough on Wednesday for several special events (this is not hard coming from the east coast or mid-west given the time change). Mel Netzhammer, Dean of the Faculty of Arts and Humanities at SUNY-Buffalo, will hold a workshop for new deans and Wendy Wilkins, Dean of the College of Arts and Sciences at Michigan State University, will host a special workshop designed for associate and assistant deans. The traditional orientation lecture to the host city will be given by Professor Ray Pestrong of San Francisco State University. A geologist, he will interweave the lively legends of San Francisco with the even livelier earthquake history. And, on Wednesday, as on every evening, we will hold the world-renowned and much envied CCAS receptions.

Over fifty session proposals have been submitted by members and the Program Committee is hard at work determining the program. The traditional case studies as well as Isaac Mowoe's sessions on Deans and the Law will be repeated by popular demand. In addition, tentative session titles listed below are high on the Program Committee's list at the present:

Updating this information ensures that we accurately represent your institution in the 2002-2003 CCAS Membership Directory.

Note that your dues payment does not have to accompany your renewal. It is imperative that confirmation of your renewal and any updates and corrections be received in the CCAS office as soon as possible. Please return the all of the renewal information promptly either using the business reply envelope provided or by fax.

Often staff and address changes are not received

before the deadline. The consequence is incorrect data on file at CCAS and in the *Membership Directory*. **Please, either confirm the accuracy of your data or inform us of changes.** Our goal is an accurate entry for you and your institution. *Note*: Because Carnegie has changed their classification system, we added Carnegie Classifications on the renewal form starting last year. Please circle the classification appropriate for your institution.

#### →<u>REMINDER ABOUT CCAS MEMBERSHIP</u>←

The CCAS Member is the <u>INSTITUTION</u> not the Dean or the individual College. When the institution calculates the number of degrees, remember to include all degree-granting colleges of arts and sciences disciplines in the total. It is up to the institution to divide the dues among the colleges. Some institutions divide the dues equally, some institutions divide the dues based upon the size of the college, and others rotate the dues responsibility between colleges on a yearly basis. Deans, please speak with your colleagues and determine your institution's method.

If a Dean moves from a CCAS member institution to a non-member institution, the Dean must apply for CCAS membership for the new institution to have the benefits of CCAS membership.

## MANAGING YOUR CCAS LISTSERV ACCOUNT

Subscribers to the CCAS Listserv may manage their list access via email directly to the listserv server. Often this will be much quicker than requesting help from the CCAS office and it is quite simple to do.

To subscribe, send the message SUBSCRIBE CCASDEAN. After the CCAS office receives the request and verifies that the subscriber is a CCAS member, the subscription will be approved.

To unsubscribe to the listserv, please send the following message to <u>listserv@asu.edu</u>: UNSUBSCRIBE CCASDEAN

NOTE: The most frequent problem occurs when extra information, such as signatures are added to the body of the message. Do not include any other text!

This list can only work if deans and their decanal staff participate and use it for communication.

# The Evolution of this Yahoo List for Academic Deans:

Many CCAS members have expressed an interest in placing ads and announcements on the CCASDEAN listserv; however, that listserv is for the discussion of issues between member deans. We created the Yahoo list to accommodate the demand for placing ads, announcements, performing surveys, etc. There may also be discussions of decanal issues on the Yahoo list, but please be aware that this list will not be as secure as some other listservs.

#### Who Can Join:

All CCAS member deans and their decanal staff will be invited to join. Additionally, non-CCAS deans and decanal staff may join this list, as well as Deans of Education, Business, Engineering, Health Sciences, etc. If you know a colleague who might be interested, please let them know about the Yahoo list. The Yahoo list has been set up such that subscription is necessary and we ask that only Deans, Associate Deans, and Assistant Deans subscribe. When you subscribe, you will be asked to provide your title and institutional affiliation. That information will not be available to the public. Every effort will be made to prevent nonacademic individuals from subscribing.

#### Advantages of a Yahoo List:

If you have not been a member of a Yahoo list before, it may be a little new to you. Lists can be as casual or as formal as the list members and moderator wish to make them.

One of the major advantages to a Yahoo list is its flexibility. If you do not want to receive a bunch of emails, you can set up your Yahoo profile to read the messages on the web or to receive a digest version (i.e., the messages for a day). To do this you must register with Yahoo. To register with Yahoo, click the URL subscription link.

Also, files, surveys, and polls can be uploaded to the site by the moderator and downloaded by list members to be completed.

#### Program Title: NSF GRADUATE TEACHING FELLOWS IN K-12 EDUCATION (GK-12) Info at

#### Synopsis of Program:

This program supports fellowships and associated training that will enable graduate students and advanced undergraduates in science, mathematics, engineering, and technology to serve in K-12 schools as resources knowledgeable about both the content and applications of science, mathematics, engineering, and technology. Academic institutions apply for awards to support fellowship activities. Institutions are responsible for: 1) selecting Fellows; 2) partnering with school districts for placement of Fellows in schools; and 3) providing appropriate training for Fellows. The Fellows will serve as resources for teachers in science and mathematics instruction. Expected outcomes include improved communication and teaching skills for the Fellows, enriched learning by K-12 students, professional development opportunities for GK-12 Teachers, and strengthened partnerships between institutions of higher education and local school districts. .....

# Course, Curriculum, and Laboratory Improvement (CCLI)

The CCLI program seeks to improve the quality of science, technology, engineering, and mathematics (STEM) education for all students and targets activities affecting learning environments, course content, curricula, and educational practices. The program has three tracks: Educational Materials Development (CCLI-EMD) projects are expected to produce innovative materials that incorporate effective educational practices to improve student learning of STEM. Projects to develop textbooks, software, or laboratory materials for commercial distribution are appropriate. Two types of EMD projects will be supported: (a) those that intend to demonstrate the scientific and educational feasibility of an idea, a 'proof of concept' or prototype, and (b) those based on prior experience with a prototype that intend to fully develop the product or practice. Such materials are expected to be disseminated nationally for adoption and adaptation.

**National Dissemination (CCLI-ND)** projects are expected to provide faculty with professional development opportunities to enable them to introduce new content

into undergraduate courses and laboratories, and to explore effective educational practices to improve the effectiveness of their teaching. Projects should be designed to offer workshops, short courses, or similar activities on a national scale in single or multiple disciplines.

#### Adaptation and Implementation (CCLI-A&I) projects

are expected to result in improved education in STEM at academic institutions through adaptation and implementation of exemplary materials, laboratory experiences, and/or educational practices that have been developed and tested at other institutions. Proposals may request funds in any budget category supported by NSF, or may request funds to purchase only instrumentation. Deadlines

**EMD** and **ND** tracks: <u>NSF 02-043</u>: Course, Curriculum, and Laboratory Improvement (**CCLI**): Educational Materials Development and National Dissemination Tracks--Program Solicitation

**A&I** track: The program solicitation covering the A&I track deadline in 2002 has not yet been published. **Publication is anticipated in March 2002.** The **CCLI** program solicitation for 2001, <u>NSF 01-58</u>, contains a description of the A&I track that may be useful to prospective proposers. However, for the latest information and instructions for submitting proposals, proposers must consult the forthcoming program solicitation for the A&I track.

National Endowment for the Humanities Funding

#### Collaborative Research

Collaborative Research grants support original research undertaken by a team of two or more scholars or research coordinated by an individual scholar that because of its scope or complexity requires additional staff or resources beyond the individual's salary.

NOTE: The Collaborative Research guidelines are currently being revised for the 2002 deadline. New guidelines will be available in March 2002. In the meantime, please refer to the information below for general information about the program and the types of projects it supports.

Who is eligible? Individuals or nonprofit, IRS taxexempt institutions and organizations in the United States are eligible for Collaborative Research grants. *Receipt Deadline:* September 1, 2002 Info at

http://www.neh.gov/grants/guidelines/collaborative.h tml Faculty Research Awards for Historically Black, Hispanic-Serving, and Tribal Colleges and Universities Awards support faculty research in the humanities and projects that enrich the humanities content of classroom teaching at Historically Black, Hispanic-Serving, and Tribal Colleges and Universities.

Who is eligible? Applicants must hold a full-time tenured, tenure track, or annual contract faculty position at a Historically Black, Hispanic-Serving, or Tribal College or University, as designated by the White House offices charged with the implementation of Executive Orders 12876, 12900, and 13021. If you are unsure of your institution's eligibility please call NEH or check the U.S. Department of Education's website. Grants under this program are not intended to support graduate course work or completion of a master's degree. The proposed project, however, may contribute to the completion of a doctoral dissertation. Scholars need not have completed work on their advanced terminal degree at the time of application. Applicants must be U.S. citizens, native residents of U.S. jurisdictions, or foreign nationals who have resided in the United States or its jurisdictions for at least three years immediately preceding the application deadline. Individuals who have received an award from this program must wait three years after the end of their award period to apply again.
